1) Call to Order – Roll Call

a) Approval of the November 18, 2024 Meeting Minutes

a) Regarding an Ordinance and Resolution for Parking on Rowell Street

Anderson requested that a reference be added to the Ordinance Public Hearing direct mailing that identifies the specific ordinance being violated if parked cars are overhanging the sidewalk.
